
### Paid Family and Medical Leave

Main sources: National Compensation Survey (Bureau of Labor Statistics), Family and Medical Leave Act Survey (Department of Labor)




## What does government data tell us?

- Employer-provided benefits
- Leave taking under FMLA



#### While workers who receive paid family leave from their employers are in the minority, the benefit has become more prominent in recent years


Percent of Workers with Paid Family Leave as an Employer Benefit, 2010-2023





#### High-wage workers and those working for large employers are the most likely to receive paid family leave as an employer benefits

Percent of workers with employer-provided paid family leave by employer size, 2010-2023



## DOL FMLA Survey, 2018

#### Department of Labor FMLA survey, 2018:

- FMLA coverage
- Frequency of leave taking
- Types of leave benefits used
  - 66% who took FMLA combined other forms of leave to get paid while on leave. Among them:
- What happens without paid leave benefit (or partial pay)
  - 76% limited spending
  - 43% used savings intended for this situation
  - 34% used savings intended for something else
- Duration

## Data Limitations

#### **Employer-Provided PFL Benefits (BLS)**

- Limited to percent of workers with access to the benefit
- No data on characteristics of the benefit, such as duration or wage replacement
- No data on frequency or duration of leave taking

#### **FMLA Data (DOL)**

- Significant lags and inconsistently provided
  - Most recent data is from 2018
  - Next most recent is from 2012

#### **State Program Data**

- No consistency in reporting
- Reported data often focuses on program performance vs individual experience

# Why these limitations matter

#### Leave taking today


- Lack an adequate understanding of employer benefits and how workers use them
- Do not have regular information leave taking behaviors
- No comprehensive understanding of who gets leave under state policies

#### **Projecting Costs**

- Considerable uncertainty about the budgetary implications of a federal PFL policy
- Driven by lack of data on leave taking

## Why are Tax Data Relevant to the Care Economy?

A growing number of policies to support families and children are administered through the tax code:

- Earned Income Tax Credit
- Child Tax Credit
- Child and Dependent Care Tax Credit
- 45S Tax Credit for Paid Family and Medical Leave
- 45F Employer-provided child care credit
- COVID-era sick and family leave credit

# General Limitations to Tax Statistics

#### Publication delays

- Topline tabulated data: lags two to three years (most recent is from 2022)
- Public-use file: Most recent is from 2015

#### Unpublished data

 SOI is unable to publish significant amount of data, including on health insurance and student debt

#### Website

- SOI does not have a standalone website
- Users must have strong working knowledge of the IRS website, existing tables, and the US tax system to answer simple questions

# Tax data limitations continued

#### Child Tax Credit

- Reports refundable and nonrefundable credit data separately
- Does not identify those claiming both
- In 2021, reported refundable, nonrefundable, and advanced CTC separately

45F Child Care Employer Credit
